June 24, 2008: J&C is officially established in Hong Kong, where it sets up headquarters. The company's main operations include the registration of Hong Kong companies, subsequent annual examinations and tax declarations.

2010年03月19日： 骏诚商务在中国深圳成立了旗下第一家国内公司，位于深圳福田，主营业务拓展香港公司有关业务市场以及代理合作，跟国内的客户，代理以及供应商可以更有效沟通，合作，以至达到共识共赢。

March 19, 2010: J&C establishes its first domestic branch in the Futian District of Shenzhen, China. Its main operations are to expand the relevant business market in agency cooperation with Hong Kong headquarters, and to more effectively communicate and cooperate with domestic customers, agents and suppliers for a win-win consensus.

2012年08月16日： 骏诚商务在英国成立了旗下第一家英国公司，位于英国伦敦，主要经营业务是英国公司注册以及后续年审，报税业务。

August 16, 2012: J&C establishes its first British branch in London, UK. Its main operations include the registration of British companies, subsequent annual examinations and tax declarations.



2017年12月04日： 骏诚商务在深圳成立了一家会计事务所，位于深圳福田，主营业务：各个代理以及终端客户税务咨询，公司做账报税/审计业务。

December 04, 2017: J&C establishes an accounting firm in Futian District, Shenzhen, China. Its main operations include tax consultation for various agents and end customers, and tax filing/auditing for companies.

2018年6月29日： 骏诚商务成功获批《香港信托或公司服务提供者牌照》，正式成为香港公司持牌代理人。

June 29, 2018: J&C was granted the "Hong Kong Trust or Company Service Provider Licence" and officially became a licensed agent for Hong Kong companies.

2013年01月01日开始： 骏诚商务拓展香港公证以及海外公证市场，全球各地商标业务，同时寻找二级，三级等香港以及英国公司代理商，积极友好的拓展代理业务，寻找更有利的供应商，使骏诚商务的客户群、代理群、供应商群更具有规模化，流程化，全面化发展。

Since January 1, 2013: J&C have expanded notarization businesses in Hong Kong and overseas markets, and trademarked businesses globally. In the meantime, the company has sought secondary and tertiary agents in Hong Kong and Britain to proactively expand business and find more favourable suppliers. The objective is to make the customer base, agency base and supplier base more scaled, streamlined and comprehensive.

2014年5月份开始： 骏诚商务开始拓展新加坡市场，美国市场，跟新加坡以及美国当地的供应商达成长久的合作，主营业务：有关新加坡注册，后续服务，开户，移民等业务；同时有关美国公司各个州注册，后续服务，开户等业务。

Since May 2014: J&C has been expanding markets in Singapore and the US, and has achieved long-term cooperation with local suppliers. Its main operations include registration, follow-up services, account opening and immigration.
